

**CONTINGENT FEE AGREEMENT FOR LEGAL SERVICES
FOR THE IRAQI COMPENSATION PROJECT NIC-F CLASS ACTION**

The undersigned, _____ employs and retains, NAZEK A. GAPPY P.C. (NAGPC), in a Class Action Petition and legal proceedings on my behalf against the Government of Iraq and Kurdistan Regional Government (KRG) or such other parties that may be deemed a proper party. I agree with NAGPC to pay then from any settlement or trial 1/3 of any sums recovered on my behalf after deduction of costs.

I also agree, in the event I have been referred by another attorney or law firm, and/or NAGPC wish to consult with another attorney or consultant outside their firms regarding my representation, they may pay such attorney from their fee that portion they feel appropriate based on the services performed and/or the responsibility assumed by each. The above fee agreement does not include fees for any Appeals. In no instance shall the total fee be more than 33.33% of the sums recovered.

I have been advised that NAGPC could be employed under a fee arrangement whereby NAGPC would be compensated for services based upon an hourly rate. It is agreed, however, that I will retain NAGPC pursuant to a contingent fee of 33.33% as described above.

In the event I decide to change attorneys in the course of the litigation, and retain substitute counsel or proceed in pro per, it is agreed that NAGPC shall at that time be reimbursed all advanced costs then outstanding, and 33.33% of the highest offer at that time, or a percentage of the ultimate fee obtained based on the contribution made by NAGPC, or an hourly rate of \$500.00 for services rendered, whichever is greater.

I further agree that should this legal matter be resolved by payment to me or my heirs of sums to be paid over a period of time rather than as a single or complete sum, I agree to pay my attorneys 33.33% of the total present value of such settlement after the deduction of costs, which shall be paid out of the sums advanced to me out of the first or principal payment. Should this first or principal payment be inadequate to fully compensate my attorneys, I also agree to pay to my attorneys 33.33% of each subsequent payment until all costs have been reimbursed and the attorney fee is fully satisfied.

I further authorize my attorneys at the close of their representation and/or within one year subsequent to my execution of the settlement agreement to destroy or otherwise dispose of my file, including x-rays, without any further notice to me. I understand that such destruction or such disposition would be done in a manner that preserves the confidentiality of their contents any my representation by NAGPC. I understand NAGPC have the right to reserve and retain their work product generated by NAGPC. I understand NAGPC has the right to reserve and retain their work product generated during their representation, including but not limited to, briefs, memos, depositions, and correspondence.

I acknowledge that I have read this Agreement before signing it and agree to be bound by its terms and have received a signed copy of it. By signing it, I agree to bind my heirs, personal representatives, and legal representatives, and any successors.

I AM SEEKING PARTICIPATION IN THIS CLASS ACTION AGAINST THE GOVERNMENT OF IRAQ (“GOI”)AND THE KURDISH REGIONAL GOVERNMENT (“KRG”) IN ORDER TO GET FAIR COMPENSATION GRANTED BY THE IRAQI CONSTITUTION AND THE UN COMPENSATION COMMISSION LAW FOR THE VIOLATIONS OF OUR RIGHTS AS IRAQI CITIZENS BY THE GOI AND KRG.
